UHS Clinical Quality Reputation, Accomplishments and Awards:

We have a longstanding, independently validated and evidence-based record of providing quality healthcare services to patients and their families:

- All UHS hospitals are fully accredited by independent organizations including The Joint Commission (TJC), whose rigorous clinical assessment protocols are widely respected throughout the healthcare industry. In our almost 40-year history, UHS has not had a facility fail to achieve accreditation or re-accreditation by any accrediting body.

- Between 2012 and 2015, 83 total UHS facilities (including 69 in our Behavioral Health Division) were designated *Top Performers in Key Quality Measures*® by TJC. TJC bestowed this award to hospitals that “attain excellence on accountability measure performance” and adherence to evidence-based clinical processes associated with improved outcomes during the course of the four year program.
- UHS Behavioral Health facilities consistently outperform the national average and their peers on other widely recognized evidence-based clinical indicators including TJC’s Hospital-Based Inpatient Psychiatric Services (HBIPS) and CMS’ Inpatient Psychiatric Facility Quality Reporting System (IPFQR) utilized by over 1,600 Behavioral Health hospitals.
- UHS Behavioral Health patients consistently report high levels of satisfaction with the care they receive at our facilities. Between 2015 and September 2017, over 300,000 UHS patients completed patient satisfaction surveys and rated their overall satisfaction during this period at 4.5 out of 5 with 92% indicating that they felt better after receiving treatment.
- Our Acute Care facilities have likewise been recognized for numerous awards and recognitions related to quality care and specialty treatment offerings from respected organizations including The Joint Commission and Leapfrog.

UHS is respected for its financial stewardship and business success in the healthcare industry. The company has built an impressive record of achievement and performance, growing from a startup into a Fortune 500 corporation (ranked #276 in 2017) with annual revenues of nearly \$10 billion.
